Respected Sir,

We would like to bring in your notice that, we have applied for NAAC accreditation & IIQA for the same also has been submitted through the HEI's Portal & also the payment has been made in respect to the application vide ref no. **01902IIQA01/2023** on 3rd June, 2023.

The most important thing after IIQA acceptance we have to submit the Section B on NAAC Manual 2023 for Affiliated colleges in the format of SSR (Self Study Report) of the Institute within 45 days as per point **VI. Procedural Details (3) mentioned in NAAC manual**, which comprises of Executive summary, profile of the college, extended profile of the college & QIF (Quality Indicator Framework) which includes 7 sub-parts.

In the above mentioned 2 parts viz. Profile of the college & extended profile of the college, we have to submit various details which are directly & indirectly related to the permanent faculty position during last five years. Regarding the faculty approval for B. Sc. Aviation course the institute has submitted proposals & requests several times within AY 2021-22 & 2022-23 to the good office of Affiliation Section, Dean office & Department of Technology but in spite of several reminders we haven't received the faculty norms from the University & due to this we cannot recruit the permanent faculty for the B.Sc. Aviation course which comes under ordinance 125.

Kindly make a note on the request to approve the proposed faculty norms as soon as possible because we have 45 days limitation to submit Self Study Report to the NAAC. As there are only 2 colleges affiliated to Savitribai Phule Pune University which runs B. Sc. Aviation UG degree program we would request you to appoint a committee which would help to fasten up the process of approval of proposed faculty norms as well as the recruitment as per university norms. If we do not submit the same as per the NAAC manual page no. 31, the institute will have to face loss of IIQA application fees & SSR submission fees (at the time of SSR submission) as per XI. The fee structure & other financial implications (1) IIQA Fee of Rs. 29,500/- & (2) Assessment and Accreditation fee of Rs. 59,000/-.
